The booth fee pays for a 10' x 10' space at the market. Artists are responsible for bringing their own tents, tent, weights, tables, chairs and displays. This is a rain or shine outdoor event. In extreme weather conditions, the market could be called early. However, occasional pop-up rain showers are not uncommon. You may wish to invest in tent sides if your products will be seriously damaged by rain.

ARTIST SELECTION: Artists are selected on the basis of Technical Skill, Originality & Creativity, Design and Composition, and Marketability. You will receive an email confirmation of your acceptance into the event. Unacceptable items include: items in violation with the Endangered Species Act, items produced from commercial kits, and work of which the balance is comprised of purchased parts. Exhibitors must display work consistent with the type and quality represented in the submission. Galloway Green Market reserves the right to require removal of objects which are inconsistent with the application submission.

SUSTAINABILITY POLICY: The Galloway Green Market encourages eco-friendly and reusable rather than “disposable” materials. Specifically, the market is “single-use plastic bag-free.” **No single-use plastic bags will be permitted at the market.** Our collective pursuit of sustainable practices will encourage our customers to develop good habits like using reusable bags, coolers, canteens, and flatware. This inherently reduces waste and minimizes our carbon footprint, giving small changes a chance to make a BIG difference!

TENT WEIGHTS: Please note if you are using a tent or canopy, tent weights of at least 20 pounds must be in place at all time. This policy is for the safety of everyone at the Market. If you do not have weights, you will not be able to erect a tent or canopy.
